It provides basic information on adoption and guardianship, the process for both options, a comparison of adoption and guardianship, and information about how the adoption and guardianship subsidy program works.

Description: Although there are several adoption agencies in Arizona, the Department of Economic Security (DES) is the largest. Almost without exception, the children placed by DES have special needs; that is, they may be older or have physical or emotional handicaps. Description: This brochure has been developed by The Indiana Department of Child Services in an effort to connect adopted children and families across the state to postadoption services. Post-adopt services are available to Indiana families who have adopted, whether they adopted through DCS or privately, until the child reaches 18 years of age. Families who adopted out-of-state (or even internationally) who now reside in Indiana are eligible for services, as well. This service is based on the belief that children and their families are remarkably resilient and capable of positive development when provided with community-centered support, defined by what is in the best interest of the child. It is meant to provide a comprehensive system of care that allows families to find support after adoption. (January 2012)

In Nebraska, potential adoptive parents must be licensed as foster parents. However, exceptions can be made for relative placements. The following section focuses on researching adoption agencies and lists key questions to ask when researching agencies. The adoption process is then described, including pre-service training, the homestudy, matching a child with a family, the placement of the child into an adoptive home, the legalization of an adoption, and post-finalization services. The next section discusses different types of financial support that may be available to adoptive parents. The handbook closes with a list of common adoption terms and contact information for public and private adoption agencies in Ohio. Profiles of adoptive families are provided throughout the handbook.
