

Kinship Caregiver Handbooks

In the event that a child must be separated from his/her parents' care, it is imperative that family connections are preserved for that child. One way to ensure that this occurs is through placement of children or youth in a home with a kinship caregiver. The NCCWE has compiled this state-by-state listing of free online handbooks. These handbooks assist kinship caregivers in navigating the child welfare system, provide answers to common questions, and list available resources.

Title: Kinship Caregivers and the Child Welfare System

Description: A number of grandparents and other relatives find themselves serving as parents for children whose own parents are unable to care for them. Sometimes, the arrangement (referred to as "kinship care") is an informal, private arrangement between the parents and relative caregivers; in other situations, the child welfare system is involved. This factsheet developed by The Child Welfare Information Gateway is designed to help kinship caregivers—including grandparents, aunts and uncles, and other relatives caring for children—work effectively with the child welfare system. It addresses a number of topics relevant for kinship caregivers such as: Different types of kinship care, including private, voluntary, and formal care; How and when the child welfare system becomes involved in kinship care; What kin caregivers might expect from the child welfare system; Services that may be available and how to access them; Involvement of the courts; Permanent living arrangements for the children; and, Resources. Title: Kinship Care Legal Handbook: A Guide for Relative Caregivers

Description: Kinship care includes the full-time care, nurturing, and protection of a child by relatives, godparents, stepparents, or any adult who has a kinship bond with the child. Some people define kinship care more narrowly to include only blood relationships. The term most often in Florida is "relative caretaker" or "relative caregiver." Whatever the label, relative caregiving has become a growing form of family life that needs to be supported. This handbook by the Florida Kinship Center focuses on the legal issues most commonly

encountered by relative caregivers and on the public benefits and services for which relative caregivers might be eligible. (2008)

Additional information and suggestions are provided on the following issues: birth parent visits, talking with children about their birth parents, understanding caregiver feelings, understanding children's issues, parenting and discipline, educational issues, transracial parenting, internet safety, preventing an abduction, children's mental health services, mental health issues, and dealing with one's own aging. Title: Considering Kinship Care

Description: This handbook was developed by the Montana Department of Public Health & Human Services Children and Family Services Division to help families understand Kinship

Care. When the state or tribe has determined that a child is unable to live in his/her own home, Kinship Care is often the best option for the child. A child will be placed with the child's family when it is in the best interest of the child, and when the home is approved by the Department. For Native American children under The Indian Child Welfare Act (ICWA), specific placement preferences are required, with placement with members of the child's extended family as the first option. Although the majority of families care for their children without legal intervention, this handbook focuses primarily on those situations where formal legal action is required in order to insure the safety and well-being of the children involved. Title: A Resource Guide for New Hampshire Relative Caregivers

Description: In New Hampshire, there are more than 10,000 children living in grandparent-headed households. Over 4,500 grandparents reported that they were responsible for their grandchildren who were living with them. There are over 2,300 children living in households headed by other relatives. Of the children living in households headed by grandparents or other relatives in New Hampshire, more than 4,000 are living there without either parent present.

Children and their caregivers are often eligible for state and federal benefits; however, finding those benefits can often be confusing and frustrating. This booklet can guide you in the right direction, help you ask the right questions, and help you find the answers you need. It was developed in partnership with the New Hampshire Department of Health and Human Services' Division for Children, Youth and Families, Division of Family Assistance, Bureau of Elderly and Adult Services, UNH Cooperative Extension, NH Relatives as Parents Program (RAPP) and Lutheran Social Services of New England.
